

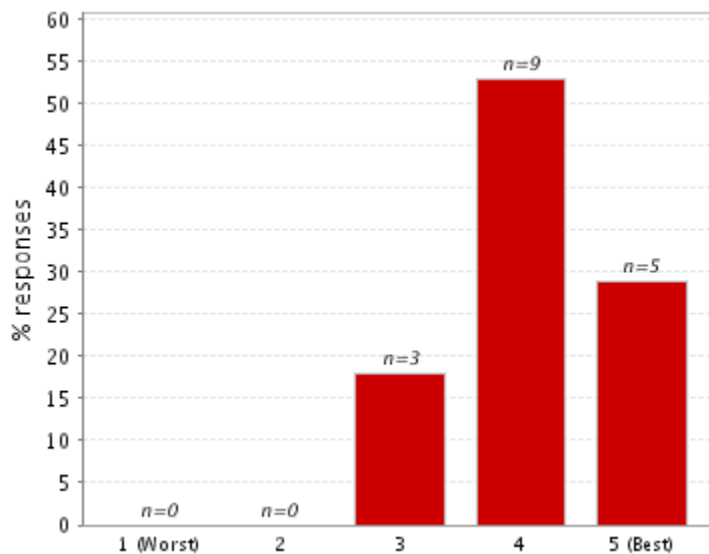

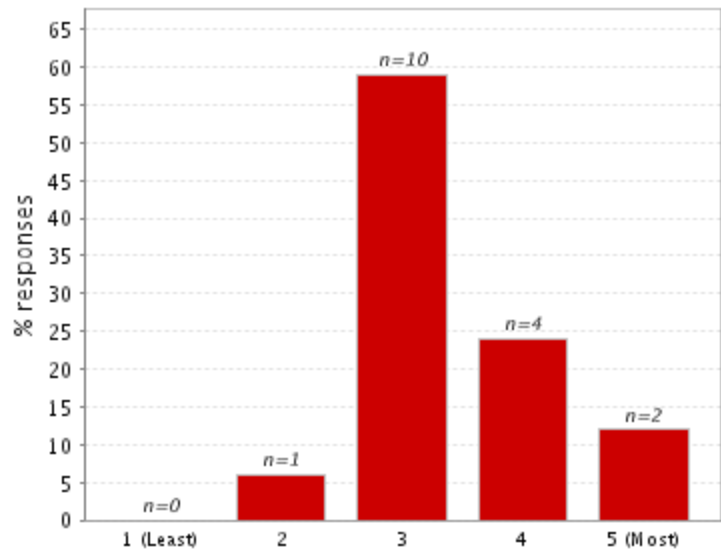

Overall, how would you rate the quality of the class materials for Criminal Procedure I?



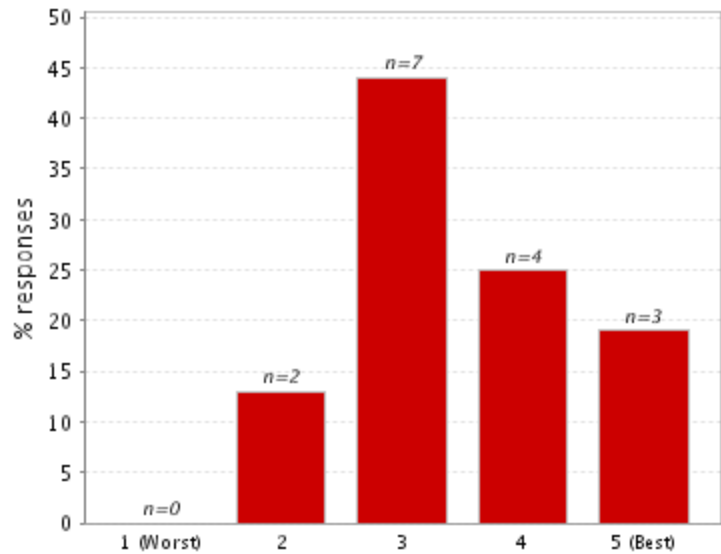
Question 2

Compared to other YLS classes, how much out-of-class preparation, reading, and writing does Criminal Procedure I require?



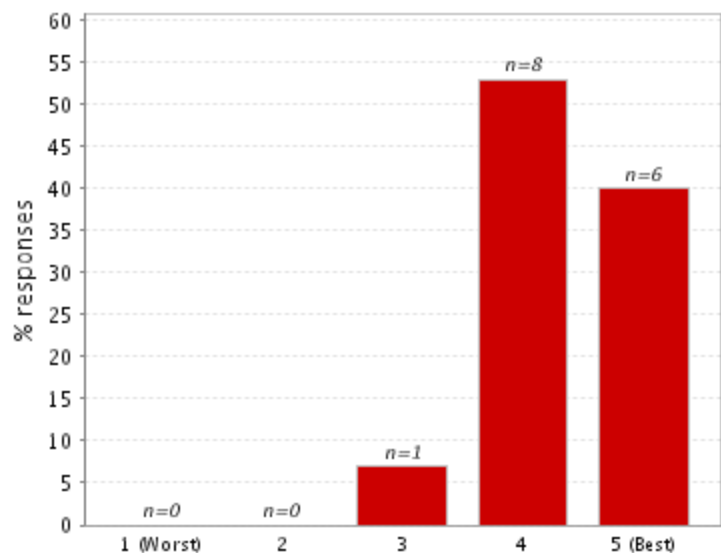
Question 3

How would you rate the professor(s)'s management of class discussions?



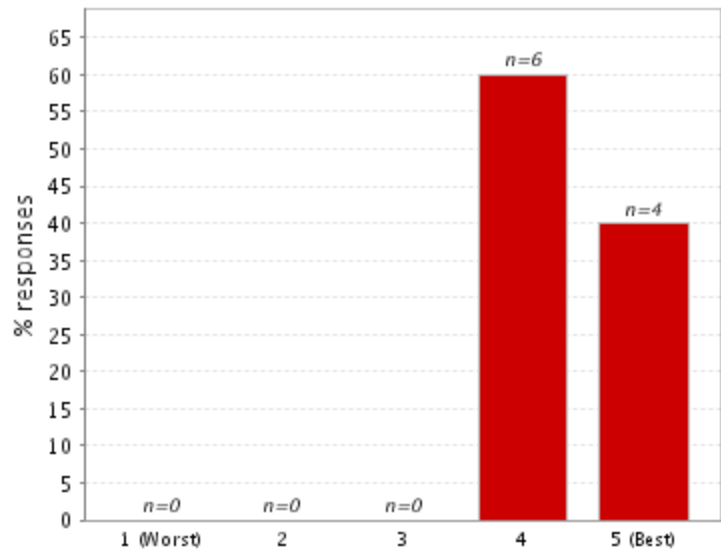
Question 4

Overall, how would you rate the professor(s)'s responsiveness to student comments, questions and concerns?



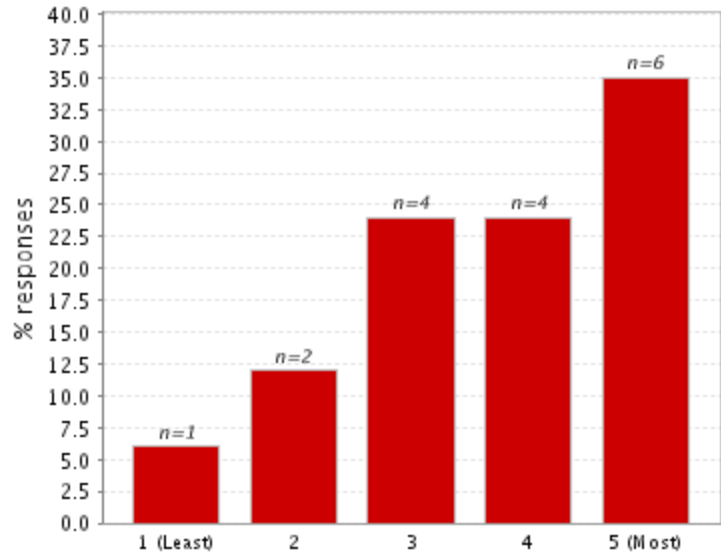
Question 5

How would you rate the professor(s)'s availability to students outside of class?



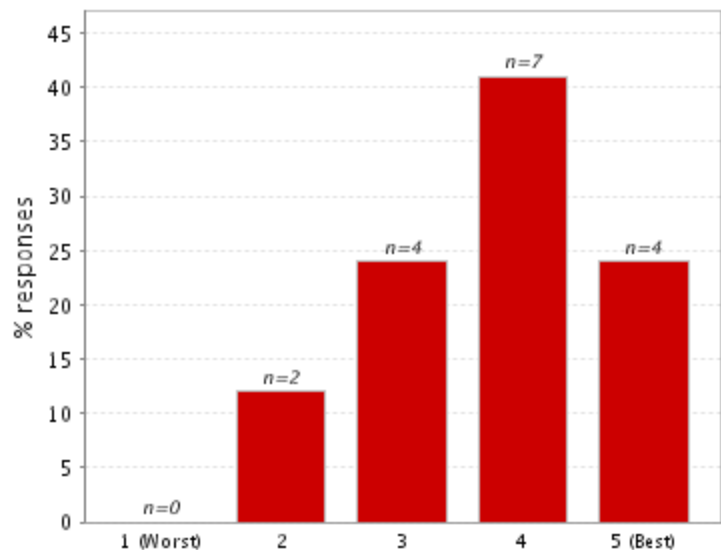
Question 6

Compared to other YLS classes, how valuable was in-class time in Criminal Procedure I?



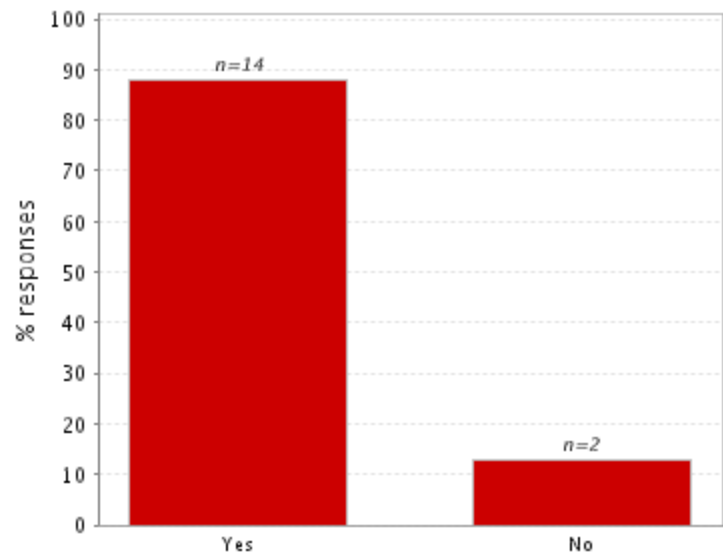

Response 1

Prof. Stein is great in this small-class setting. He teaches a lot of the black letter material from pre-trial through habeas, and adds interesting theoretical content as well. Fun sense of humor and very responsive to student questions.

Response 2

The reading material was interesting, but overwhelming (80+ pages per class meeting), and while Stein obviously knows the topic very well, the class discussion was less than engaging and the lectures relatively unorganized.

Response 3

Stein definitely takes an economic approach to criminal procedure. That doesn't mean he skips over important parts, but he does spend extra time on issues he sees as conducive to economic theories. He seems to care a lot about what he is teaching and that the students are understanding. He was responsive to student questions and issues and always seemed willing to take extra time to explain things we didn't understand. And he doesn't cold call.

Response 4

Professor Stein is among the finest instructors I've had in law school. He is the rare professor who generates brilliant ideas, expresses them in compelling and coherent ways, and gives generously of his time and insights to students. As a research supervisor, he met with me frequently, read my work with care, and provided the searching criticisms and warm encouragement that developed a research idea into a completed paper. Professor Stein is a gifted teacher. Bring him to Yale.
